The Village of Hanna City, Peoria County, Illinois, an Illinois Municipal Corporation, hereby gives Notice of a Public Hearing to be held at **6:00 pm, Central Daylight-Saving Time, on August 18, 2020**, at the Hanna City Village Hall, 313 N. First Street, Hanna City, Illinois, to consider its proposed approval of the Hanna City Business Development District No. 1 Plan and the designation of the proposed Business District Redevelopment Area.

To promote social distancing and due to capacity limitations set forth in the Governor's Executive Orders and Disaster Proclamations as well as State guidelines, only a limited number of public members will be physically present at the Public Hearing. It is possible that no members of the public may fit in Village Hall and that Village Board Members may not be physically present. Those attending electronically or by phone will be required to provide their name and address and the Hearing will be recorded.
